Coral Street Arts House is now accepting applications for our waiting list.

Coral Street Arts House is the product of NKCDC's commitment to the arts in our community. It is a residential project for low income artists and all others who qualify under the income guidelines. It is located at 2446-68 Coral Street at the corner of Coral and Hagert Street in the East Kensington section of Philadelphia.

There are 27 one and two bedroom apartments that offer modern kitchens and baths, hardwood floors, carpeting, and air conditioning. Six units are designed to accommodate the needs of persons with mobility or sensory impairments. Each apartment offers a flexible floor plan that affords studio space. Each floor's hallway provides lighting and hardware for the display of art. There is also a community room available for use by the residents. **Utilities are not included.**

Applicants to Coral St Arts House must qualify under the income guidelines set forth by the Pennsylvania Housing Finance Agency Please see the PHFA.org website for income guidelines.

Coral Street Arts House is looking for artists at any point in their career, but dedicated to their craft. Coral Street is a close community committed to the advancement of the arts for each individual and in the community at large. Coral Street was founded on the belief that art can be a force for positive change in the lives of all community members. Non-artists are welcome to be a part of this special community.

Artist Criteria for Preferential Status

1. Applicant should demonstrate that they have worked and are currently working towards specific artist goals in one (or more) of any variety of genres (fine art, dance, theatre, photography, writing, craft, music, spoken word, or graphic arts).
2. Applicants should have a clear written statement of their artistic goals long term (over one year) and short term, and how they plan to achieve them.
3. Applicants must demonstrate a commitment to pursuing their art form. The applicant should also be able to prove a previous commitment to the art form (one cannot say that they are “going to take up their art again” once they have been accepted).
4. Applicants must come to the interview with a body of work (minimum 10-12 pieces with some common relationship or theme). No work should be over one year old. All work should be presented in a professional manner – presentation counts!
5. Applicants must be able to articulate some of the concerns, themes, or ideas behind their body of work.
